

REGULAR MEETING

June 18, 2020

The regular meeting of the Long Lake Board of Supervisors was called to order at 5:00 ;.m. by Chari David Jonson. Present were Supervisors Thomas Malloy and Darryl Moser, Treasurer Virginia Smart and Clerk Patsy Olson. Also present were: Ron Rardin, James Rollie, John and Pat Westerberg. Pledge of allegiance was given.,

Minutes of the previous meetings were read and approved as corrected. Treasurer's report was approve, subject to audit.

Johnson contracted Mike's Tree Service for estimate to remove the trees from the town hall lot, not Joel Jacobson as stated in the May minutes.

Malloy reported that steps had not been installed at the end of First Street, Paradise Beach.

The request by John and Pat Westerberg to rezone 5 acres to sell would not set a prescient as each request is considered separately. Motion made by Malloy to approve with the specification that this did not set a prescient, second by Moser and carried with all voting in favor.

Johnson received a phone call from Tony and Melissa Kaufenberg about a GPS survey of Lake Avenue and Hawaii Avenue. Rollie stated that measurements had not been done yet. Lot 24 is bigger than previously thought. Crow Wing Power has started to trim the area. Johnson will talk to his contact at CW Power.

Weidel Point Road: Johnson talked to Sheriff Scott Goddage about parked vehicles blocking the road. He was told that the road could not be blocked to emergency vehicles. He has not received a response from e-mail to County Attorney Don Ryan. He will follow up.

Gilbert Lane: work has been finished.

Well site: Crow Wing Power Round Up Program might help with funding. Johnson to write an application and ask Brainerd Fire Chief to sign off. There was a concern about the amount of equipment already there. A transformer on the ground is a possibility.

Motion by Johnson to have Mike's Tree Service cut the trees at the town hall if the estimate is less than \$2,000.00 estimate from Brad Holmwig. Second by Malloy and carried with all voting in favor.
