## REGULAR MEETING OCTOBER 15, 2020

The regular meeting of the Long Lake Board of Supervisors was called to order at 5:00 p.m. by Chair David Johnson. Minutes of the September and road inspection were read and approved. Treasurer's report was given and approved, subject or audit.

Jodran Larson, Crow Wing County Highway Dept. gave an update on the bridge replace on County Road 23 scheduled for next summer. The old bridge will be replaced with two 14X9 foot culverts. The bridge will have a width of 36 pavement and total of 84 feet width. There will be no guard rails necessary with the 84 foot width. Contractor will be responsible for keeping birds from nesting under the bridge. Construction will begin around June 1st. and the road will be closed for approximately 3 weeks.

Road mileage certification: clerk to certify as no change at 28.245 miles.

Johnson moved to pass a resolution expending CARES funds and transferring remaining funds to Crow Wing County. Second by Malloy and carried with all voting in favor.
