Johnson will call Zak Brix about snowplowing the town hall yard so that snow is not piled up in front of the door and not to push the cover off the septic tank.

Cemetery actuary tabled.

Phil Munsch zoning request to change his conditional use permit to allow for up to 15 employees instead of 5. Motion by Johnson to approve request. Second by Malloy and carried with all voting in favor.

Clancy Olson, TV Service Center discussed the necessary equipment needed for a projector for meetings and took measurements of the wall that will be used. He will send the estimate to Johnson.

Covid funding in the amount of \$26,800.00 has been deposited in the bank. County could not give funds back to the township. Unused funds can be transferred to the county. Johnson explained the spending for I Pads. After discussion, Johnson moved to use funds to purchase 5 Max I pads. WIFI service and contract for maintenance, HP 15.6 lap top with solid state and maintenance contract fir the clerk , install projector and screen for the town hall, training for using the I Pads, possible web site, If Mat attorney, Steve Fenske approves, new flooring for the town hall building. Seconding by Malloy and carried will Johnson, Malloy and Moser voting in favor.
