## REGULAR MEETING MARCH 17, 2022

The regular meeting of the Long Lake Board of Supervisors was called to order at 5:00 p.m. by Chair David Johnson. Minutes of the previous meeting were read and approved. Treasurer's report was given and approved, subject to audit.

Richard Wear requested a variance to rebuild a garage after a tree fell on it. He wanted to add 10 feet to the front requiring a variance to place it closer to County Road 22. Crow Wing County highway department wants 50 feet from the center line. Motion by Johnson, seconded by Malloy and carried to support the variance request.

Johnson has not heard back about time for replacing the town hall door.

ARPA resolution to spend funds as lost revenue replacement was presented to the board. Motion by Johnson, seconded by Malloy to approve the resolution. Carried with all voting in favor.

Bill Shook passed on a compliment to the town board for the good job of snow plowing that was done. He also stated that the culvert at the end of Paradise Beach Road is sinking. The board will look at it while doing spring road inspection.

Rardin stated that he would be gone May 10-25 and wanted to know if it was ok to put up flags on veteran's graves before he left. Supervisors said he could.

Spring road inspection was set for Friday, April 15<sup>th</sup> starting at the town hall at 8:00 a.m.
