## REGULAR MEETING August 15, 2024

Lakeview Drive: The culvert has been installed but there is still a lot of brush in the ditch. Johnson to contact Holmvig.

Wicklund Road: Culvert is plugged. Johnson to have Holmvig clean the culvert.

Hilltop View Road: Johnson to get a cost estimate to make a 50 foot radius turn around from Holmvig.

Lakeside Road: possibly add speed bumps, 10 mile advisory speed limit signs. Supervisors to talk with Mat attorney at District meeting.

James Rollie: Paradise Beach Road, Johnson to contact KLD Surveyors to see if any changes were made to the survey done by CWC. Clerk to contact Planning and Zoning and see if they have made any changes.

Petition to vacate Third Street, Paradise Beach: Knutson stated that the agreement giving easement to the township was all right. The township would have to pass a resolution to make it a town road.
