REGULAR MEETING September 19, 2024

The regular meeting of the Long Lake Board of Supervisors was called to order at 5:45 p.m. by Chair David Johnson. Present were: Supervisors Thomas Malloy and Mark Olson, Treasurer Virgina Smart, Deputy Clerk Lisa Olson and Clerk Patsy Olson. Also present were: Dale Spalding, Deb Morgan, Mallory and Brian Kramer, Brad Baker, Denise Baker, Sue Erhotlz, Caryn Baker, Carter Endrizz, Tom Stizacn, Rick Krahulec, Chuck Kaphing, Darrel Palmer, Sue Norr and Sue Erholtz.

Minutes of the August meeting were read. Motion by Olson, seconded by Malloy and carried to accept. Treasurer's report was given. Motion by Malloy to approve, subject to audit, seconded by Olson and carried.

Brad Baker, Church Road, is requesting a CUP to build two home (for himself and daughter) and an event center. The event center would operate primarily on the weekends with a maximum of 300 people and 100 vehicles. They would encourage guests to carpool. The septic system was discussed. The township comp. plan has the property as rural preservation. They would use the vendor's liquor license. He has not contacted any of the neighbors to get their input. County hearing is set for October 17. Johnson to reach to other townships to see if they have similar event centers. Residents attending the meeting were not in favor of the proposed request. Reasons stated were: Traffic and safety on the road and additional noise. Dave to email clerk when he has more information. No other action was taken.

Darrel Palmer, Central Lakes ATV Club, requested that the club use Oakridge Road surface from Thiesse Road to Thompson Road for the ATV trail as the ditch is too wet. This is a grants-in-aid trail and the trail ambassadors patrol the trail for problems. The trail could be posted as 30 mph. Motion by Olson, seconded by Malloy to allow Oak Ridge Road to be used temporarily with a 30mph speed limit. Motion carried with all voting in favor.

Johnson to investigate the website to see if the township needed to change to a .gov site.

Fall road inspection: Johnson will be gone. Malloy to contact Brad Holmvig to see if he wanted to be present. Road inspection was set for Monday, September 30 meeting at the town hall at 9:00 a.m.

October meeting changed to Friday, October 18th. Clerk to post notice at the town hall and Johnson will post on the website.

Butternut Road: Johnson to contact Tim Bray, CWC Highway engineer, if more fill is needed at the intersection with County Road 144.

Lakeside Road: The town board talked with MAT attorney Madeline Cash about no parking on the road. She stated that the township should put up signs even if the county would not enforce this for the township. Johnson asked to have her send this in an email.

Lake Avenue: have the road staked for boundaries.

Church Road: Supervisors agreed to install two 30mph advisory signs. See if the County Highway Department has the signs.

Correspondence was discussed.
