REGULAR MEETING NOVEMBER 21, 2024

The regular meeting of the Long Lake Board of Supervisors was called to order at 5:30 p.m. by Chair David Johnson. Present were: Supervisors Thomas Malloy and Mark Olson, Treasurer Virginia Smart, Deputy Clerk Lisa Olson and Clerk Patsy Olson. Also present were: Dale Spalding and Gary Hanson. Pledge of Allegiance was given.

Minutes of the October meeting and the Board of Canvas were read. Motion to approve by M. Olson, seconded by Malloy and carried.

Treasurer's Report was given. Motion to accept, subject to audit, by Malloy, seconded by M. Olson and carried.

Spalding reported that potholes on Paradise Beach Road. Holmvig will still do it this fall.

Hanson wanted to know why the roads were graded when it has been so dry that the calcium chloride was graded off the road. Contract with Holmvig states that grading will be done when the supervisors deem necessary.

Johnson made a motion to pass a resolution to pay a bounty on gophers at \$2.00 and beavers at \$85.00, seconded by M. Olson and carried with all voting in favor.

Speed limit on Paradise Beach Road and Paradise Beach Trail were discussed. Motion by Johnson, seconded by M. Olson to approve a resolution to set the speed limit at 35 m.p.h. Motion carried with all voting in favor.

Raskinski Door Service, the handicapped door will have to be repainted to repair the sticking seal. M. Olson will check.

Bill for road vacation was discussed. Clerk to bill Thomas and Debra Morgan for township attorney fees plus other expenses.

Crow Wing County hazard mitigation plan was discussed. The township must participate to be eligible for FEMA reimbursement. The main concern is flooding in low areas around the lake and Wicklund Road. Johnson will take the survey.

Road construction specifications were discussed. Clerk to retype the specifications making the following changes in section 7. A 50 foot radius turn around in any clud de sac. For the township to accept the road, 80% of the lots must be occupied.

Lakeside Road: No parking on the west side of the road. A 10 m.p.h. advisory speed limit sign. Possible speed bump. No action was taken at this time.

Lakeside Road: the debris that was left when the culvert was replaced has not been picked up. None of the work from the fall road inspection has been done. Clerk to resend by email and regular mail.

Township web site: the site will be changed from .com to .gov.

The bill from Holmvig was discussed and denied at this time. Questioned why the roads were graded when it was so dry? Johnson will contact Holmvig about this and the work still to be done.

DRT meeting for Hanson property will be on Monday, November 25, 2024. The township will push for five (5) acre lots. This will allow for a backup septic system and well if necessary.
