

REGULAR MEETING  
AUGUST 19, 2025

The regular meeting of the Long Lake Board of Supervisors was called to order at 5:30 p.m. by Chair David Johnson. Present: supervisors Thomas Malloy and Mark Olson, treasurer Virginia Smart, dep. clerk Lisa and clerk Patsy Olson. Also present: Larry and Julie Dibblem Dale Spalding and Ron Rardin. Pledge of Allegiance was given.

Motion by Olson, seconded by Malloy and carried to approve the minutes of the July meeting as presented. Motion by Malloy, seconded by Olson and carried to approve the treasurer's report, subject to audit. Motion carried.

The question was raised about filling holes in Paradise Beach Road.

Cemetery: Marking the lots for winter was discussed. Motion by Johnson to approve the purchase of 200 corner markers, 50 fence posts and 200 feet of rebar. Motion seconded by Olson and carried. Clerk stated that someone wanted to purchase plots in lot 54 in the NW corner where there is brush. No action was taken on this issue. Clerk also stated that a marker had been put on Busbey grave but did not have the required cement base. Clerk to notify the family that this has to be done.

District 8 meeting: Officers will leave at 3:30 p.m. M. Olson will drive.

Fall road inspection set for Saturday, September 6 at 8:00 a.m. at the town hall.

Parking lot: the asphalt has been replaced. Johnson has requested quotes for striping from Richard Munsch and Katelyn Thesing-Yezek. The board decided that two (2) handicapped spaces are needed, one (1) on each side of the ramp. Parking spaces to be ten (10) feet wide.

Subdivision ordinance: Mission township has completed theirs. Johnson to have Attorney Knutson review.

Mogensen Shores driveway damage: Holmwig requested that the township split the bill for repairs that the property owners had done. Motion by Malloy and second by M. Olson to agree. Motion carried with all voting in favor.

Lakeside Road: "No parking this side" signs have been installed.

Brookside Beach: Kraemer informed Johnson that he had filed the necessary survey. Johnson to have him forward a copy of the survey and agreement to the clerk.

Lake Avenue: "Public Road" signs are up on one side. Clerk to order two (2) more signs.
