

REGULAR MEETING
JANUARY 20, 2026

The regular meeting of the Long Lake Board of Supervisors was called to order at 5:30 p.m. by Chair David Johnson. Pledge of allegiance was given. Present were: Supervisors Tom Malloy and Mark Olson, Treasurer Virginia Smart, Deputy Clerk Lisa Olson and Clerk Patsy Olson. Also present were Marlee Morrison and Amanda Peterson, representing Sourcewell.

Minutes of the December meeting: Motion to approve made by M. Olson, seconded by Malloy and carried. Treasurer's Report given: Motion by Malloy to approve, subject to audit, seconded by Olson and carried.

Sourcewell representatives gave a presentation of the services available to the township. The township is considering seeking funding for technical upgrades, including upgrades to I pads and camera system for the townhall. Approval is needed before any work is done. Line item quotes must match. No purchase before the application is approved. There will be a clerks/treasurer workshop in Staples on January 28.

Board of Audit was set for the February 17th. meeting.

The road maintenance contract expires on May 1, 2026. The bid requirements will be discussed at the next meeting.

Lakeview Drive: Olson reported that residents have been putting leaves and tree branches in the ditch. Johnson to compose a letter for the clerk to send to all residents on Lakeview Drive. A copy of the ordinance to be included.

Brookside Beach: Attorney suggested that the township vacate the portion of the platted that is being used for septic system. A public hearing must be done first. The property owners pay all costs. They would have to be notified and approve before any action can be taken.

Lake Avenue: If James Rollie removes but then replaces obstacles in the road, the township could then take legal action and it becomes a criminal offense.

Morgan deed: Motion by Olson, seconded by Malloy to proceed with transferring property that was exchanged with a quick claim deed. This would change the property from Morgan to the township. All voting in favor.

Subdivision ordinance: A public hearing has to be held before adopting. Johnson to check with MAT attorney if this could be held at the annual meeting in March.

Board of Appeal and Equalization: Set for Tuesday, April 21 @ 1:00 p.m. This is the same day as the regular meeting. Johnson stated that he will be gone on that day. Possibly change the regular meeting.
